## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 11, 2024, placed the rating(s) of Tirupati Agro Oils Private Limited (TAOPL) under the 'issuer non-cooperating' category as TAOPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TAOPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 25, 2025, February 04, 2025 and February 14, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of TAOPL have been revised on account of non-availability of requisite information.

The company operates from manufacturing facilities located at Kadi (Gujarat) with an installed capacity of manufacturing 60 Tonnes per day as on March 31, 2019.
