### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 17, 2024, placed the rating(s) of Vichita Estate And WareHousing Private Limited (VEWPL) under the 'issuer non-cooperating' category as VEWPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VEWPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 03, 2025, March 13, 2025 and March 23, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Established in February 1989, Vichita Estate and Warehousing Private Limited (VEWPL) as a private limited company and was engaged in providing warehousing facility of Chemicals till 2006. In the year 2006 the aforesaid company was taken over by Mr. Varinderkumar Sohanlal Arora & Mr. Ravikumar Sohanlal Arora and was kept idle from 2006 till March 2017. In April 2017, the promoters of the company planned to set up a cold storage plant at MIDC, TTC Industrial Area, Village Bonsari & Kukshet, Juinagar, Navi Mumbai.
