AK continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 02, 2025, March 12, 2025, March 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
