## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 04, 2024, placed the rating(s) of InkeL-Ekk Roads Private Limited (IRPL) under the 'issuer non-cooperating' category as IRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. IRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 18, 2025, January 28, 2025, February 07, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of IRPL have been revised on account of non-availability of requisite information.

## **About the Company**

Inkel-EKK Roads Private Limited (IRPL), incorporated in 2016, is a Special Purpose Vehicle (SPV) through Joint Venture between Inkel Limited (Inkel, rated CARE C; Stable; Issuer Not Cooperating / CARE A4; Issuer Not Cooperating / CARE C (FD); Stable; Issuer Not Cooperating) and EKK Infrastructure Limited for the construction, operation and maintenance of a 58 km road project in Kerala on Design, Build, Maintain and Transfer (DBFMT) on Annuity basis. The company has entered into a Concession Agreement (CA) with Road Infrastructure Corporation of Kerala Limited (RICK) for a period of 15 years, which includes the construction period of 2 years. The company achieved COD on April 02, 2018 which was around 145 days ahead of the scheduled completion date of August 25, 2018.
