Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 22, 2024, placed the rating(s) of Vishavkarma Agro Industries (VAI) under the 'issuer non-cooperating' category as VAI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VAI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 08, 2025, March 18, 2025 and March 28, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
