## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated July 12, 2019, placed the rating of Reliance Big Entertainment (US) (RBEUS) under the 'issuer non-cooperating' category as RBEUS had failed to provide information for monitoring of the rating exercise as agreed to in its Rating Agreement. RBEUS continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 23, 2025 and April 03, 2025, among others and numerous phone calls. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
