## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 17, 2024, placed the rating(s) of Tahir Construction (TC) under the 'issuer non-cooperating' category as TC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 03, 2025, March 13, 2025 and March 23, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

It has undertaken number of contracts for Atal Mission For Rejuvenation and Urban Transformation (AMRUT; Ministry of Housing and Urban Affairs, Government of India) and Neer Nirmal Pariyojana (providing clean drinking waters to villages).
