### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated March 18, 2024, placed the rating(s) of A-1 Cold Storage Private Limited (ACSPL) under the 'issuer non-cooperating' category as ACSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ACSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 01, 2025, February 11, 2025 and February 21, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

A1 Cold Storage Private Limited (ACSPL) was incorporated in the year 2015 with its registered office at Somajiguda, Hyderabad. The promoters of the company are Mrs. Duvvuru Varija (Managing Director) and Mrs. Bollu Hymavathi (Director). Both the directors have experience for more than two decades in agricultural business. Presently, the company is establishing a cold storage plant at Jadcherla village, Mahabubnagar District, Telangana with the total project cost of Rs. 8.92 crore which is to be funded through a bank term loan of Rs.5.55 crore and balance of Rs.3.37 crore from promoter's fund. Till date, the company has incurred Rs.0.77 crore for land registration and development purpose. ACSPL is planning to start its commercial operations from December 2018. The company is expected to preserve fruits, vegetables and other agricultural products like seeds post completion of cold storage plant.
