Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 11, 2024, placed the rating(s) of Trishul Dream Homes Limited (TDHL) under the 'issuer non-cooperating' category as TDHL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TDHL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 25, 2025, March 07, 2025 and March 17, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
