Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated February 27, 2024, placed the rating(s) of Jharkhand Ispat Private Limited (JIPL) under the 'issuer non-cooperating' category as JIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated January 12, 2025, January 22, 2025, February 01, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of JIPL have been revised on account of non-availability of requisite information.

Analytical approach: Standalone revised from Combined

For arriving at its ratings, earlier CARE had combined the business and financial risk profiles of Alope Steel Industries Private Limited (ASIPL), Araanya Mines Private Limited (AMPL), Jharkhand Ispat Private Limited (JIPL) and Maa Chhinnmastika Cement And Ispat Private Limited (MCCIPL) as these are under common management and have significant operational and financial linkages. However, updated information is not available to ascertain financial linkages. Hence, the analytical approach is revised to 'Standalone' from 'Combined'.

About the company

JIPL, incorporated in 1991, was promoted by Jharkhand-based Mr. Ram Chandra Rungta and his brother Mr. Ram Swarup Rungta. The company was initially engaged in dealing of spare parts. Later, in 2003, the company shifted to the manufacturing of sponge iron and MS Billets by setting up its plant in Ramgarh, Jharkhand. The current capacity of sponge iron unit is 1,20,000 MTPA and Billets unit is 78,990 MTPA. Other companies belonging to the RC Rungta group are Alope Steel Industries Pvt Ltd which is engaged in manufacturing of sponge iron with an installed capacity of 120,000 MTPA and Maa Chhinnmastika Cement & Ispat Pvt. Ltd. engaged in the manufacturing of sponge iron (90,000 MTPA). The aggregate installed capacity of the group for sponge iron is 3,30,000 MTPA and for billets is 78,990 MTPA. The group has also formed various Joint Ventures to carry on coal mining and handling activities for Mahanadi Coalfields Ltd.
