Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated May 13, 2024, placed the rating(s) of Kaushal Ferro Metals Private Limited (KFMPL) under the 'issuer non-cooperating' category as KFMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KFMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 29, 2025, April 08, 2025, April 18, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of KFMPL have been revised on account of non-availability of requisite information.

About the company

Kaushal Ferro Metals Private Limited (KFMPL) was incorporated in December 2004 to initiate an iron and steel products manufacturing unit. However, after incorporation, the company remained dormant and started commercial operation during the year 2007. The company installed a sponge iron manufacturing unit at Sundargarh district in Odisha with an installed capacity of 60,000 MTPA. Mr. Sitaram Agrawal (Director), Mr. Ganesh Agrawal (Director) and Mr. Ram Bihari Upadhayay (Director) looks after the day-today activities of the business along with other three directors and a team of experienced personnel.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KFMPL into ISSUER NOT COOPERATING category vide press release dated April 25, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
