## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 17, 2024, placed the rating(s) of Shri Balaji Rollings Private Limited (SBRPL) under the 'issuer non-cooperating' category as SBRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025 and April 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to the bank facilities of SBRPL have been revised on account of non-availability of requisite information.

SBRPL was incorporated as private limited company in the year 1994 by Late. Mr. Rajender Prasad Singla, the founder of Singla Group. The registered office and the manufacturing facilities of SBRPL are located at Salcete, Goa. SBRPL is engaged in manufacturing of MS (Mild Steel) Billets. The group company "Arya Steels Rolling (India) Limited" is associated with manufacturing of TMT bars since 2008.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of SBRPL into Issuer Not Cooperating category vide press release dated August 06, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
