Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 21, 2024, placed the rating(s) of Shri Salasar Agro Processors (SSAP) under the 'issuer non-cooperating' category as SSAP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSAP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 06, 2025, April 16, 2025 and April 26, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

Established in June 2013, SSAP is a Nagpur-based (Maharashtra) entity engaged in extraction of soya bean oil. The firm also sells the by-product, i.e., de-oiled cake to traders in vicinity of Nagpur.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of SSAP under Issuer Not Cooperating category vide press release dated July 05, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.

CRISIL has continued the rating assigned to the bank facilities of SSAP under Issuer Not Cooperating category vide press release dated March 28, 2024 on account of its inability to carry out a review in the absence of the requisite information from the firm.
