Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 16, 2024, placed the rating(s) of Desh Bhagat Memorial Educational Trust (DBMET) under the 'issuer non-cooperating' category as DBMET had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DBMET continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 01, 2025, April 11, 2025 and April 21, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The objective is also to open educational institutions to arrange for the upkeep and education of the destitute and poor children, especially girls and make arrangements for their survival, protection and all-round development through charitable schemes. The trust has established six separate colleges, namely, Shaheed Udham Singh (SUS) College of Engineering & Technology (SUSCET), SUS Engineering College (SUSEC), SUS College of Research & Technology (SUSCRT), SUS Institute of Computer (SUSIC), SUS Polytechnic College (SUSPC) and SUS College of Pharmacy (SUSCOP). All the institutes of DBM are in Mohali, Punjab. The different courses offered are duly approved by AICTE (All India Council of Technical Education), PTU (Punjab Technical University), Punjabi University and Punjab State Board of Technical Educational & Industrial Training (PSBTE & IT), Chandigarh.
