## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated May 13, 2024, placed the rating(s) of Sangam Rice Private Limited (SRPL) under the 'issuer non-cooperating' category as SRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 29, 2025, April 08, 2025 and April 18, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Sangam Rice Private Limited (SRPL) was incorporated in 2007 as a Private Limited company and is currently being managed by Mr. Sanjiv Kumar and Mrs. Shubh Lata as its directors. The company is engaged in processing of paddy and milling of rice at its manufacturing facility located at Patran. The company is also engaged in trading of guar seed and rice.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of SRPL into 'Issuer not-cooperating' category vide press release dated February 13, 2025 on account of non-availability of requisite information from the company.
