Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 06, 2024, placed the rating(s) of Govindam Projects Private Limited (GPPL) under the 'issuer non-cooperating' category as GPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 22, 2025, April 01, 2025, April 11, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of GPPL have been revised on account of non-availability of requisite information.

About the company

Govindam Projects Private Limited (GPPL) was incorporated in February 2003 to initiate a sponge iron manufacturing business. The company has set up its manufacturing unit at Kuarmunda, Rourkela in Odisha. Since its inception, the company has been engaged in manufacturing of sponge iron and from FY16 the company has also started iron ore crushing unit in its existing plant.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of GPPL into ISSUER NOT COOPERATING category vide press release dated September 10, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.

Infomerics has continued the rating assigned to the bank facilities of GPPL into ISSUER NOT COOPERATING category vide press release dated January 15, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
