### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 08, 2024, placed the rating(s) of Sree Saravana Engineering Bhavani Private Limited (SSEBPL) under the 'issuer non-cooperating' category as SSEBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSEBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 24, 2025, April 03, 2025, April 13, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

SSEBPL was established as a partnership firm (Sri Saravana Engineering Works) in 1981 by Mr P Venkatchalam and Mrs V Poongodi (w/o Mr P Venkatachalam) and was converted into a private limited company in December 2010. SSEBPL undertakes hydromechanical operations, including designing, procurement, fabrication, manufacturing, installation, testing, and commissioning of hydro-mechanical equipment, predominantly in power projects as well as in irrigation projects in Tamil Nadu and Kerala.

**Status of non-cooperation with previous CRA:** Infomerics has moved the rating assigned to the bank facilities of SSEBPL into ISSUER NOT COOPERATING category vide press release dated September 23, 2024 on account of its inability to carry out a review in the absence of requisite information from the company.

Brickwork has continued the rating assigned to the bank facilities of SSEBPL into ISSUER NOT COOPERATING category vide press release dated May 05, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
