Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 15, 2024, placed the rating(s) of F3 Marine Foods Worldwide (FMFW) under the 'issuer non-cooperating' category as FMFW had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FMFW continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 31, 2025, April 10, 2025, April 20, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the firm

F3 Marine Foods Worldwide is a registered partnership firm with 8 partners who have experience of more than 2 decades in the business of marine products. It is established with the objective of setting up fish processing unit along with ice plant and cold chain infrastructure in Gujjarbettu, Udupi, Karnataka. The main objective of the firm is to export marine products. Inputs would be procured locally and neighbouring districts. The firm has set up integrated cold chain and value addition infrastructure project for marine products at the same location. Further, the firm has set up Farm Level Infrastructure (FLI) including processing center situated at the catchment area of coastal district of Karnataka. This includes Cold storage unit, frozen storage/deep freezers, blast freezers and plate freezers.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of FMFW into ISSUER NOT COOPERATING category vide press release dated June 12, 2024 on account of its inability to carry out a review in the absence of requisite information from the firm.
