Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 16, 2024, placed the rating(s) of R. L. Steels And Energy Limited (RLSEL) under the 'issuer non-cooperating' category as RLSEL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RLSEL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 01, 2025, April 11, 2025 and April 21, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.
