## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated May 24, 2024, placed the rating(s) of Pal Enterprises - Delhi (PED) under the 'issuer non-cooperating' category as PED had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PED continues to be non-cooperative despite repeated requests for submission of information through emails dated April 09, 2025, April 19, 2025, April 29, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Pal Enterprises - Delhi (PED) was established in August, 1985 as a partnership firm and is currently being managed by Mr. Amreek Singh Kapoor, Mr. Gulbir Singh Chopra and Mr. Surjeet Singh Kapoor sharing profit and losses in the ratio of 37:37:26. The firm is engaged in to manufacturing and export of leather garments to European countries. It has its manufacturing unit located in Okhla (Delhi).

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of PED into Issuer Not Cooperating category vide press release dated March 08, 2024 on account of its inability to carry out a review in the absence of requisite information.
