# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 29, 2024, placed the rating(s) of Annapoorani Yarns (AY) under the 'issuer non-cooperating' category as AY had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AY continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 15, 2025, March 25, 2025, April 04, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### **About the Firm**

Annapoorani Yarns (AY) was established as a partnership concern in 2000 by Mr. R Jayachandran and Ms. J Thavamani with equal profit-sharing ratio. AY is engaged in trading of blended yarns like poly cotton, poly viscose etc. and grey and finished fabric. The yarn is purchased from suppliers located in New Delhi, Punjab and Tamil Nadu. The firm deals with 20s-40s counts of yarn. The yarn purchased is fabricated into grey cloth and finished fabric on job work basis and sold to customers located in Tamil Nadu. The registered office of the firm is located in Tirupur, Tamil Nadu.

**Status of non-cooperation with previous CRA:** ICRA has continued the ratings assigned to the bank facilities of AY to the 'issuer not-cooperating' category vide press release dated December 27, 2024 on account of its inability to carryout review in the absence of requisite information from the firm.
