## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated May 24, 2024, placed the rating(s) of Earthen Treasures Natural Resources Private Limited (ETNRPL) under the 'issuer non-cooperating' category as ETNRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ETNRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 09, 2025, April 19, 2025 and April 29, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

ETNRPL was established in April 2013. Promoted by Mr Aniket Jain and Mr Pratyush Bharatiya, operations of the company began from April 22, 2013. ETNRPL is currently engaged in quarrying, production and trading of granite. ETNRPL has leased the quarry measuring 2.13 acres from M/S Brothers Granite Exporter and has acquired rights of selling, supplying, and trans porting of black granite blocks for a lease period of 7 years. The quarry of the entity is located in Chamrajnagar, Karnataka.
