Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 26, 2024, placed the rating(s) of Shree Narshingha Cold Storage Private Limited (SNCSPL) under the 'issuer non-cooperating' category as SNCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SNCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 12, 2025, March 22, 2025, April 01, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.
