# Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 13, 2024, placed the rating(s) of Sandcity Autotec Private Limited (SAPL) under the 'issuer non-cooperating' category as SAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 29, 2025, April 08, 2025, April 18, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

# **About the company**

SAPL was incorporated in June, 2014 by Shri Shiv Kumar Poddar and Shri Ankit Poddar of Balasore, Odisha. However, the company commenced operations from January, 2015. It is an authorized dealer of Hyundai Motor India Ltd (HMIL) for its passenger vehicles, spares & accessories in Balasore, Odisha. Currently, SAPL has its only vehicle showroom and workshop at Balasore (Odisha) where it also provides repair and refurbishment services for HMIL passenger vehicles

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SAPL into ISSUER NOT COOPERATING category vide press release dated April 17, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
