### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 16, 2024, placed the rating(s) of A.R.T. Fabrication Industries Private Limited (AFIPL) under the 'issuer non-cooperating' category as AFIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AFIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 01, 2025, April 11, 2025 and April 21, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Haryana based A.R.T Fabrication Industries Private Limited (AFIPL) was incorporated in August, 1995 as a private limited company and is currently being managed by Mr. Jatinder Singh Grover and Mr. Harinder Singh Grover. The company is engaged in the manufacturing of crane parts such as bumper of cranes, compactor chassis, counters weights, frames, etc. other associated sheet metal components and electricity panels at its manufacturing facility located in Faridabad, Haryana.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of AFIPL into Issuer Not Cooperating category vide press release dated April 10, 2024 on account of its inability to carry out a review in the absence of requisite information.
