## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 17, 2024, placed the rating(s) of Shri Paharimata Cold Storage Private Limited (SPCSPL) under the 'issuer non-cooperating' category as SPCSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPCSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025 and April 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### **About the company**

Shri Paharimata Cold Storage Private Limited (SPCSPL) was incorporated in December 04, 1972 and currently the company is being managed by Mr. Ranjit Kumar Dandapat, Mr. Sukamal Dandapat and Mrs. Moutusi Dandapat. Since its inception; the company has engaged in cold storage services mainly for preservation of potatoes. The cold storage unit of the company is located at West Midnapore, West Bengal with an aggregate storage capacity of 138829 quintals. Moreover, the company has not availed any moratorium from its lender.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of SPCSPL into Issuer Not Cooperating category vide press release dated June 24, 2024 on account of its inability to carry out a review in the absence of requisite information.
