### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 19, 2024, placed the rating(s) of Jai Bhagwan Ji Food Products (JBJFP) under the 'issuer non-cooperating' category as JBJFP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JBJFP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 05, 2025, March 15, 2025 and March 25, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

Sihora - based (Madhya Pradesh (M.P.)) JBJFP was formed as partnership firm on August 15, 2016 by Mr. Manojkumar Sahajwani, Mr. Inderkumar Sahajwani and Mr. Mohit Sahajwani. JBJFP commenced its manufacturing operations for sorting and polishing of non- basmati rice from August 2016 onwards, from its manufacturing plant located at Sihora, M.P. Further, it also trades in rice and paddy according to market opportunities. Waste and by-product during manufacturing of rice are sold as a cattlefeed in local mandis. Further, JBJFP also trades in Gram and Gram dal as a commission agent. The associate concerns of JBJFP include M/s. Jai Bhawani Traders, M/s. Jai Gurudev Food Products, M/s. Jaidev Kirana Stores which are also engaged in the agrocommodities related businesses.
