## **Rationale and key rating drivers**

CARE Ratings Ltd. had, vide its press release dated May 21, 2024, placed the rating(s) of Omicron Power Engineers Private Limited (OPEPL) under the 'issuer non-cooperating' category as OPEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OPEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 06, 2025, April 16, 2025 and April 26, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

#### About the company

Aurangabad-based (Maharashtra) OPEPL was initially established as a partnership firm in 1990 and later in 2010 was converted into a private limited company. OPEPL is a turnkey power infrastructure development company engaged in execution of power infrastructure works like erection and commissioning of substations, transmission line setup for government, semi-government and private organizations.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of OPEPL under Issuer Not Cooperating category vide press release dated June 24, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
