Rationale and key rating drivers

CARE Ratings Limited (CARE Ratings) has withdrawn the rating assigned to the non-convertible debenture (NCD) issue (bearing ISIN no. INE787D08021) of Balkrishna Industries Limited (BIL) with immediate effect, as the company has repaid the aforementioned NCD issue in full along with interest, and there is no amount outstanding under the issue as on date.

Incorporated in 1961, BIL is engaged in manufacturing specialty tyres, known as OHT which caters to agriculture, industrial, construction, earthmoving, mining, port, lawn & garden, and all-terrain vehicle (ATVs) tyres with over 3,200 SKUs as on December 31, 2024. The company primarily caters to more than 160 countries in the exports markets of Europe, America, and Australasia. The company has five tyre manufacturing plants in India at Waluj (Maharashtra), Bhiwadi, (Rajasthan), Chopanki, (Rajasthan), and Bhuj, (Gujarat) and a carbon black manufacturing facility at Bhuj, (Gujarat), a windmill at Jaisalmer (Rajasthan), and a mould plant in Dombivli, (Maharashtra). Post brown field capex, the achievable capacity of tyre plants stood at 360,000 MTPA. The company also has backward integration for its carbon black requirements; additionally, it is also sold in the market.
