### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 17, 2024, placed the rating(s) of Surya Plastics Manufacturing Private Limited (SPMPL) under the 'issuer non-cooperating' category as SPMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025 and April 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Bhiwani (Haryana) based Surya Plastics Manufacturing Private Limited (SPMPL) was incorporated as a Private Limited Company in 2012 by Mr. Keshav Aggrawal and Ms. Ruchi Aggarwal. The company commenced its operation in January 2016. The company is engaged in manufacturing of non -woven fabric and Poly Propylene (PP) tape. The key raw material i.e. Plastic granules are procured from distributors of Reliance Industries Limited (RIL), IOC Ltd and Haldia Petro Chemicals Ltd and also from open market of Delhi and local traders in Bhiwani (Haryana). The company markets non-woven fabric through dealers located in Delhi, Haryana and Rajasthan etc.
