## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 08, 2024, placed the rating(s) of Vesta Equipment Private Limited (VEPL) under the 'issuer non-cooperating' category as VEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 22, 2025, March 04, 2025, March 14, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

## **About the Company**

Vesta Equipment Private Limited (VEPL) was incorporated in May, 2010 and is promoted by Mr. R. Balasubramanian and Mr. Sam Alumkal Thampi of Bangalore, Karnataka. The company is engaged in designing, development and manufacturing of diesel engine driven portable screw air compressor in technical collaboration with M/s. Sullair Corporation, USA. Currently the company manufactures three kinds of air screw compressors which are utilized in water well drilling, coal bed methane drilling, geothermal, underbalanced drilling etc. The manufacturing unit of the company is situated at Bangalore.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of VEPL into Issuer Not Cooperating category vide press release dated June 26, 2024 on account of its inability to carry out a review in the absence of the requisite information from the company.
