### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 17, 2024, placed the rating(s) of VTC Engineering Private Limited (VEPL) under the 'issuer non-cooperating' category as VEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. VEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 03, 2025, March 13, 2025, March 23, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the Company

VEPL was incorporated as a partnership firm in the year 1978 by three brothers, namely, Mr. V Narsimham, Mr. V Nageswara Rao and Mr. V Dhananjaya Rao to carry out the business of trading in air conditioners, water coolers, scooters and other electrical items. In the year 1987, the partnership firm was converted into a private limited company. Subsequently, the nature of business was changed to Engineering, Procurement and Construction (EPC) contractor in the Engineering Sector. Initially, the company was engaged in executing only electrical works for defence organizations. Over the years, the company has slowly moved its focus towards executing turnkey projects, for other segments, which includes civil, electrical and mechanical works.
