### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 19, 2024, placed the rating(s) of Shri Balaji Wire (SBW) under the 'issuer non-cooperating' category as SBW had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBW continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 05, 2025, March 15, 2025 and March 25, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Katni (Rajasthan) based SBW was formed in April 2015 by Mr. Manoj Kumar Tanwani and Mr. Raj Kumar Tanwani by converting the proprietorship firm of Mr. Manoj Kumar Tanwani. SBW is engaged in manufacturing of wire products since 2008. The major products of the firm include Barbed Wire, Wired Nails, M.S. Wire and Chain Jali. SBW purchases raw material from Raipur and Bhilai and sells its finished products to dealers located majorly in Uttar Pradesh and Madhya Pradesh. The firm uses brand name of Tiger Super and ShaktiMaan for barbed wire and wired nails respectively.
