## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 17, 2024, placed the rating(s) of Lakshmi Saraswathi Textiles (LST) under the 'issuer non-cooperating' category as LST had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. LST continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025, April 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

LST is a proprietorship concern established in the year 1982 by Mrs Vijayalakshmi, supported by her husband Mr T.A. Rajah. LST was engaged in trading yarn and fabric in the domestic market till 2004. Since 2005, they are into manufacturing fabric and started concentrating on the export market. After the demise of Mrs Vijayalakshmi in the year 2007, the full control of operations was taken over by Mr T.A. Rajah. It has an installed capacity of 55 lakh meters per annum.
