Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 17, 2024, placed the rating(s) of Ujjwal Luxury Hotels Private Limited (ULHPL) under the 'issuer non-cooperating' category as ULHPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ULHPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025 and April 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Ujjwal Luxury Hotels Private Limited (ULHPL) was incorporated in June, 2011 as a private limited company by Mr. Bhagirath Poonia and Mr. Daya Ram Poonia with an objective to establish a three-star hotel at Jaipur (Rajasthan). ULHPL has completed construction work on the hotel in the middle of November 2015 and has started its operations from December 2015. The hotel has a facility of total 75 deluxe rooms along with one restaurant cum bar and one banquet hall with capacity of 400 persons.
