### Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 21, 2024, placed the rating(s) of AKL Infracon Private Limited (AIPL) under the 'issuer non-cooperating' category as AIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. AIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 06, 2025, April 16, 2025, April 26, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

### About the company

AKL Infracon Private Limited (AIPL) was initially set up as a proprietorship entity in the name of 'AK Engineers' in the year 1982. Later in June 2013, it was incorporated as a private limited company and the name of the company was changed to the current one. Currently; the company is managed by the three promoters Mr. Arup Kr Som, Mrs Lila Som and Mr. Sayantan Som. Since its inception, the company has been engaged in civil construction activities in the segment like construction of buildings, road, bridge, water supply system etc.

**Status of non-cooperation with previous CRA:** ICRA has continued the rating assigned to the bank facilities of AIPL into ISSUER NOT COOPERATING category vide press release dated March 12, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
