Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 02, 2024, placed the rating(s) of Tilak Ram Babu Ram Private Limited (TRBRPL) under the 'issuer non-cooperating' category as TRBRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. TRBRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 18, 2025, March 28, 2025 and April 07, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

TRBRPL is an ISO 9001:2008 certified company, incorporated in May 2012 and promoted by Mr. Raj Kumar Garg and Mrs. Dimple Garg. TRBRPL is primarily engaged in trading of cotton bales (income from trading constituted ~70% of the total operating income in FY16). The company also undertakes cotton ginning & pressing at its processing facility located in Tohana, Haryana. The cotton bales are further sold to spinning mills through commission agents based in northern and central India.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of TRBRPL into 'Issuer not-cooperating' category vide press release dated April 04, 2025 on account of non-availability of requisite information from the company.

BRICKWORK has continued the ratings assigned to the bank facilities of TRBRPL into 'Issuer not-cooperating' category vide press release dated January 16, 2025 on account of non-availability of requisite information from the company.
