Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 26, 2024, placed the rating(s) of Fortune Spirit Limited (FSL) under the 'issuer non-cooperating' category as FSL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. FSL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 12, 2025, March 22, 2025 and April 01, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Fortune Spirit Limited (FSL) was incorporated in 2007 by Mr. Deepak Kumar Sahu (Chairman) and his brother Mr. Rajesh Kumar Sahu (MD). Both of them are having an experience of more than two decades. They are supported by Mr. Ayush Sahu (son of Mr. Deepak Kumar Sahu). The Company is engaged in bottling and manufacturing of India Made Foreign Liquor (IMFL) with installed capacity of 4,50,000 cases per annum at Gopalpur, Odisha.

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of FSL into Issuer Not Cooperating category vide press release dated February 11, 2025 on account of its inability to carry out a review in the absence of the requisite information from the company.
