## Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated April 30, 2024, placed the rating(s) of SNR Edatas Private Limited (SEPL) under the 'issuer non-cooperating' category as SEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 16, 2025, March 26, 2025, April 05, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

SNR Edatas Private Limited (SEPL) formerly known as Satyanarayana Raju Company Private Limited was incorporated in 2012 by Mr. T.V.S.N. Raju and Mr. P. Bangaru Raju with an objective to take over the running division of Socio-Economic Caste Census Project carried on by M/s/ Satyanarayana Raju & Co., Hyderabad. Mr. T.V.S.N. Raju (qualified Charted Accountant) initially set up a Chartered Accountant firm in the year 1976 under the name Satyanarayana Raju & Co. with a purpose to deliver all levels of financial services across the spectrum. With market change being driven by technology, the firm also ventured into the software architect & solution provider space under a separate division as Satyanarayana Raju & Co. (SECC division). In the year 2012, SEPL took over the software division of Satyanarayana Raju & Co (SECC division) with the object of becoming a major player in the e-Governance space.
