Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 09, 2024, placed the rating(s) of Rishabh Constructions Private Limited (RCPL) under the 'issuer non-cooperating' category as RCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 25, 2025, April 04, 2025 and April 14, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

Jaipur (Rajasthan) based RCPL was incorporated in November 1984 and is promoted by Mr. Mahendra Kumar Sethi and Mr. Madan Lal Sethi. RCPL is engaged in execution of civil construction contract works with major focus on construction of buildings, refurbishment/modification of buildings, hospitals, sophisticated & complex laboratories, water supply & sewage disposal and electrical engineering works. It is a 'SS' (highest in the scale of SS to E) class approved contractor from Military Engineer Services (MES) and 'AA' class approved contractor from Central Public Work Department (CPWD). The company also undertakes civil construction work for private clients. It also has a windmill in Jaisalmer with a total installed capacity of 1.25 Mega Watt (MW).
