Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 02, 2024, placed the rating(s) of Buildsworth Industries LLP (BIL) under the 'issuer non-cooperating' category as BIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 18, 2025, March 28, 2025, April 07, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the company

BIL was formed on January 8, 2019, promoted by Mr Amit Agarwal (Agarwalla group of Guwahati), Mr Nitesh Jain (Jain group of Jorhat) and Ms Banita Jain (Jain group of Dibrugarh) as partners. The firm has been formed for setting up a green field project to manufacture AAC blocks at Dibrugarh, Assam. The project cost is envisaged at Rs.27.76 crore and the expected date of commencement of commercial operations is April 2021.
