## **Rationale & Key Rating Drivers**

CARE Ratings Ltd. had, vide its press release dated May 17, 2024, placed the rating(s) of Kufri Fun Campus Private Limited (KFCPL) under the 'issuer non-cooperating' category as KFCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KFCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 02, 2025, April 12, 2025, April 22, 2025 among others.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

## **About the company**

Kufri Fun Campus Private Limited (KFCPL) was incorporated in 2006 and started its commercial operations in August, 2013 and is promoted and managed by Mr. Baldev Singh Thakur and Mr. Vikas Agarwal. KFCPL owns and operates a theme park called 'Kufri Fun Campus' located at Shimla, Himachal Pradesh. KFCPL also owns and operates Food and Beverages (F&B) outlets, retail and merchandise shops as well as banquet hall inside the theme park. Apart from this, KFCPL has provided hotel named 'Twin Towers' on lease to Colors of India Tours Private Limited w.e.f. April 2018.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of KFCPL into Issuer Not Cooperating category vide press release dated June 12, 2024 on account of its inability to carry out a review in the absence of requisite information.

CRISIL has continued the rating assigned to the bank facilities of KFCPL into Issuer Not Cooperating category vide press release dated April 28, 2025 on account of its inability to carry out a review in the absence of requisite information.
