Rationale and key rating drivers

CARE Ratings Ltd. had, vide its press release dated May 24, 2024, placed the rating(s) of Ace Brain Systems And Software Private Limited (ABSSPL) under the 'issuer non-cooperating' category as ABSSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ABSSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 09, 2025, April 19, 2025 and April 29, 2025 among others. In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

The ratings have been revised on account of non-availability of requisite information.
