# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 12, 2024, placed the rating(s) of RPN Engineers Chennai Private Limited (RECPL) under the 'issuer non-cooperating' category as RECPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RECPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated February 26, 2025, March 08, 2025, March 18, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

# **About the Company**

RECPL was established as a proprietorship firm (M/s. Lookmans Engineering Contractors) in 1995 by Mr. P.K. Luqmman Basha and was reconstituted into a private limited in May 1999 in Chennai. RPN is engaged in the business of civil and mechanical constructions like laying of pipes for state and central government agencies and contract work for the Indian railways.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of RECPL to the 'issuer not-cooperating' category vide press release dated January 14, 2025 on account of its inability to carryout review in the absence of requisite information from the company.
