# **Rationale and key rating drivers**

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 21, 2024, placed the rating(s) of Suyog Anjani Avishkar Associates (SAAA) under the 'issuer non-cooperating' category as SAAA had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SAAA continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 07, 2025, May 17, 2025 and May 27, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
