Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 05, 2024, placed the rating(s) of Jay FE Cylinders Limited (JFCL) under the 'issuer non-cooperating' category as JFCL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JFCL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 21, 2025, May 01, 2025, May 11, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Users of this rating (including investors, lenders and the public at large) are hence requested to exercise caution while using the above rating(s).

The ratings assigned to bank facilities of JFCL have been revised on account of non-availability of requisite information.

About the company

Jay FE Cylinders Ltd, incorporated in the year 2008, is an ISO 9001:2008 and ISO/TS 16949:2009 certified business entity engaged in manufacturing of high-pressure seamless cylinders for storage of high-pressure gases such as compressed natural gas (CNG) for auto industry. Company has collaboration with JFE Containers and Marubeni Automotive (Japan) for providing technical know-how to Jay FE Cylinders Ltd. In May 2020, JFECL was merged into Lizer Cylinders Limited (group entity) and post-merger Lizer Cylinders Limited (LCL) changed its name to Jay Fe Cylinders Limited. The company has 2 manufacturing plants located in Bawal, Haryana and Gandhidham, Gujarat.

Status of non-cooperation with previous CRA: BRICKWORK has continued the ratings assigned to the bank facilities of JFCL into 'Issuer not-cooperating' category vide press release dated March 19, 2025 on account of non-availability of requisite information from the company.
