### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 13, 2024, placed the rating(s) of Essel Walajahpet Poonamallee Toll Roads Private Limited (EWPTRPL) under the 'issuer non-cooperating' category as EWPTRPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EWPTRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 29, 2025, May 09, 2025 and May 19, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratingss opinion is not sufficient to arrive at a fair rating.

EIL has been awarded the four to six laning of the Poonamallee (Km 13/8) Walajahpet (Km 106/8) section of NH4 in the state of Tamil Nadu by National Highway Authority of India (NHAI) under design build finance operate and transfer (DBFOT) basis covering a length of approximately 93.00 km.
