Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 30, 2024, placed the rating(s) of P.P. Automotive Private Limited (PAPL) under the 'issuer non-cooperating' category as PAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 15, 2025, April 25, 2025 and May 05, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

P.P. Automotive Private Limited (PAPL) was set up in 2004 as a partnership firm named P.P. Automotive by Mr Prem Pal Bhamba and Mr Rajesh Bhamba, in Karnal. It was reconstituted as a private limited company in 2009 by the name of PAPL. The company has an exclusive dealership business of Passenger Vehicles and Commercial Vehicles for Mahindra & Mahindra Ltd in its six showrooms in Haryana. The company also offers servicing of vehicles and sale of spare parts and lubricants. PPAPL is a part of the P.P group, which has other firms viz. Nirmal Motors (engaged in the auto dealership business of Hero Motocorp Ltd.) and P.P. Autotek Pvt Ltd (engaged in the auto dealership business of Volkswagen).
