# Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 16, 2024, placed the rating(s) of Renex Industries Private Limited (RIPL) under the 'issuer non-cooperating' category as RIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 02, 2025, March 12, 2025, March 22, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Renex Industries Private Limited was earlier incorporated in 2010 by Mr Premraj Pamate Chalavaraj, Mr Ashish Bipinkumar Soni and Mr Ravi Banarasilal Kapoor as Swathi Sunsource Power Private Limited (SSPPL) to setting up unit to manufacture solar collectors/equipment's i.e. Parabolic Troughs, which can be used by clientele to generate heat/steam/power at its manufacturing facility located at Industrial Part Penukonda, Anantapur District, Andhra Pradesh. Furthermore, the company also has in-house research and development facility at Penukonda, which is partially functional.
