Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 04, 2024, placed the rating(s) of Woodville Palace Hotel (WPH) under the 'issuer non-cooperating' category as WPH had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. WPH continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 20, 2025, April 30, 2025 and May 10, 2025 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the firm

Woodville Palace Hotel (WPH) was established in April, 1977 as a proprietorship concern and is currently being managed by Mr. Kanwar Uday Singh, as its proprietor. The firm is running a hotel with the name of "Woodville Palace Hotel" on ~5 acres of land in Shimla, Himachal Pradesh. The hotel comprises of total 27 rooms, along with 1 banquet hall, 1 bar, 1 restaurant, 1 lounge, 1 dining hall and parking area for around 30 cars.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of WPH into Issuer Not Cooperating category vide press release dated August 29, 2024 on account of its inability to carry out a review in the absence of requisite information.
